The New Mexico Gay Men's Chorus is a community chorus. Its sole mission is to reduce homophobia and intolerance, create understanding, strengthen the LGBTQ community, and build a bridge of tolerance to the larger community through high-quality musical performances. The Chorus has roughly 60 singing members, led by an artistic director and supported by a number of volunteers ranging from Board members to event support. During the 2018-2019 season, the Chorus presented three major concert series in Albuquerque and Santa Fe to a total estimated audience of about 3,400. It also performed at various community events.
