

The New Mexico Gay Men's Chorus is a community chorus. Its sole mission is to reduce homophobia and intolerance, create understanding, strengthen the LGBTQ community, and build a bridge of tolerance to the larger community through high-quality musical performances. The Chorus has roughly 60 singing members, led by an artistic director and supported by a number of volunteers ranging from Board members to event support. During the 2020-2021 season, the Chorus was unable to perform its normal schedule of in-person concerts due to the COVID-19 pandemic. Instead, the Chorus presented four virtual concerts presented over YouTube and Facebook; three concerts were presented free of charge (with requests for donations), while the final concert was ticketed. The Chorus expects to return to its normal schedule of three in-person concert series during the 2021-2022 season. Prior to COVID-19, the Chorus also performed at various community events.
